

2017 Budget Message

December 21, 2016

As Coroner, I herewith submit the 2017 Proposed Operating Budget for the Jefferson Parish Coroner's Office.

As required by law, I present a budget evidencing a complete fiscal plan which contains the following:

- Budget Message
- Detailed Estimate of Revenue
- Detailed Estimate of Expenditures

This is a balanced budget. The total of estimated revenues of \$5,967,625.00 exceeds the total of proposed expenditures of \$5,933,750.00. Both revenues and expenditures are projected to be at or about the same levels as 2016. This budget is driven by our desire to continue to provide those services required under Louisiana law:

- Death Investigations
- Mental Health Evaluations
- Sexual Assault Examinations

Since being elected Coroner, it has been my sincere desire to wisely manage the tax dollars entrusted to me in support the Jefferson Parish Coroner's Office. I believe that we have accomplished that mission while at the same time, expanding the services provided to citizens of Jefferson Parish.

2016 was a millage reassessment year. The Jefferson Parish Coroner's Office as a taxing body collects two millages which provide the funding necessary to operate the Office. After careful consideration the decision was made to not roll the Coroner's Office's millages forward thus creating a tax break to the citizens of Jefferson Parish.

Again, the 2017 proposed budget presents a fiscally sound approach to the finances of the Jefferson Parish Coroner's Office. We shall always strive to provide financial stability and to insure that the growing needs of the citizens of Jefferson Parish are met.
